The Supreme Court of the Philippines, the highest court of the land led by Honorable Chief Justice Alexander G. Gesmundo, conferred UNC with the HISTORY MAKER, the Historical Building Marker for the UNC's commitment and unique role as the only local testing center in Bicol during the first-ever localized and digitalized Bar Examinations dubbed as #BestBarEver2020 21. This month, UNC opens its gates once more for the BAR Exams.Best Bar Ever Chairperson, Honorable Senior Associate Justice Marvic Mario Victor F. Leonen expressed his gratitude to UNC during the event hosted at the UNC campus. Supreme Court dignitaries who also graced the historic occasion were Associate Justice Amy C. 
Employability #first with IBM
